## INSTRUCTIONS-PEDDLER'S LICENSE

The attached application for a Peddler's License consists of the following documents which should be completed and routed as indicated:

- 1. APPLICATION PAGE-Complete all sections and return to the Town Clerk with owner's letter of permission, State vendor's license (if required), fee and item number 2.
- 2. PEDDLER'S STATEMENT AND APPRAISAL-Complete all sections and return as indicated above. Upon notification of the tax assessed, such fee must be paid to the Clerk or no further review of the application will be scheduled.
- 3. APPLICATION FOR A SIGN-Review the zoning ordinance for the district in which your license will apply. Submit a sketch of the proposed sign, to include dimensions, lighting and proposed location, to the Zoning Administrator, along with items numbered 1, 2, and 4. No application will be approved if the sign ordinance is exceeded.
- 4. SITE PLAN-Draw to scale the portion of property which will be used for sale of goods, identifying all physical features, existing and/or proposed, permanent and/or temporary. Include access highway numbers, adjacent buildings, streams. The plan must include site distances in each direction from the access and/or egress as well as a north arrow.

The completed plan must be submitted to the Zoning Administrator and will thereafter be placed on the next agenda of the Planning Commission, for its review.

Copies of the sign approval and the approved site plan will be returned to the Board of Selectmen, along with the Application page, owner's permission, the Listers' certification, a copy of the applicant's State Peddler's License and certification of payment of the fee and tax as assessed by the Clerk. If the application is deemed complete, the Board of Selectmen will notify the Clerk, who will then issue the license.
